### **PLEASE NOTE: ALL APPLICATIONS FOR THE SPRING ART CRAWL ARE DUE BY APRIL 6, 2018.**

1. Complete Application Form and send payment online or by mail. Individual Artist fee \$20/Art Gallery fee \$20. PLEASE MAKE CHECKS PAYABLE TO: Downtown Statesville Development Corporation (or DSDC).
2. All artists must submit three images of your work for consideration. Submissions may be by e-mail (info@downtownstatesvillenc.org) or mail to P.O. Box 205, Statesville, NC 28687. If you want your material returned, please include a self-addressed stamped envelope to fit your juried material.
3. All work displayed at the Art Crawl must be original fine art created by the applicant.
4. All materials used to create art must reflect a majority of handcrafted components. For three-dimensional works such as jewelers and sculptors, silver-smithing, weaving and sculptural manipulation of materials is required (i.e. straight beading would not be an acceptable submission unless the beads were handcrafted).
5. All individual artists will be juried and contacted regarding acceptance. If not chosen, the fee will be returned.
6. You will be notified approximately 2 weeks prior to the Crawl of your display location. We encourage artists to partner with downtown businesses. Please let us know of any arrangements you have made with a particular downtown business to display there. Otherwise, artists will be placed with a downtown business by the Committee.
7. Display space may vary by location and artists are responsible for all items required to display artwork. Set-up time should be worked out between the business owner and artist. The Art Crawl begins at 5:30 pm and ends at 8:30 pm.
8. Artists are responsible for all sales and sales taxes. Please make sure you have money available to make change if you are selling artwork.
9. Once your work is juried and accepted, there will be no refunds unless the event is cancelled by DSDC. Weather will not be cause for cancellation of the event. In no way will the Downtown Statesville Development Corporation, or event sponsors be held responsible for lack of sales, lack of viewers, the weather, or its effect on the event.
